Please note that no request for any change in particulars is to be accepted under any circumstances after the specified date for online correction is over. After correction a revised confirmation page printout should be taken.

Their candidature by the appointing authority, however, shall be considered only when they have acquired the minimum qualification.		
18	Whether such candidates are eligible to appear in HTET who has completed their graduation from IGNOU that is through open mode and teacher training course such as Diploma in Elementary Education from regular mode simultaneously in the same academic session or year but in different modes graduation from open and D.EL.ED from regular mode?
